## 54 FOUNDERS AWARD

*The League's highest honor is given to an individual, group, or organization judged to have made an outstanding contribution to the conservation of America's natural and renewable resources. Only one can be awarded per year, and in some years an award is not made if no candidates are deemed worthy. **Charles "Chuck" Clayton** (South Dakota)

Chuck Clayton has been an avid conservationist and Ike for decades, working on a range of conservation issues at the local, state, and national levels.

He has served as the League's national president (2003-2005), national vice president (2001-2003), and a member of the Executive Board for close to a decade. He currently chairs the League's Public Lands Committee and previously chaired the Resolutions Committee. Locally, he served as president of his chapter as well as president and vice president of the South Dakota Division.

Clayton wrote a weekly outdoor column for the *Huron Plainsman* for several years, has been published in numerous conservation magazines and periodicals (including *Outdoor America*), and even had his own outdoor radio show focused on environmental issues. He was part of the Izaak Walton League's task force on the Alaska National Wildlife Refuge and testified before the U.S. Senate on how to interpret the Supreme Court's *Rapanos* decision as it applies to the Clean Water Act. He is recognized throughout South Dakota as a spokesperson for conservation, annually testifying before the state legislature, and has been one of the state's strongest advocates for protecting wetlands and native prairie. He worked countless hours to help create the Tony Dean Acres legacy, which will set aside several hundred acres of habitat for public use and youth education, and on efforts to create a dedicated conservation fund in South Dakota.

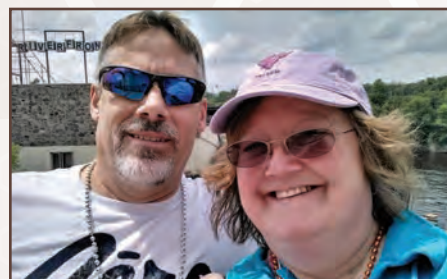
In 1999, Clayton was awarded the League's national Conservation Award. He was named the South Dakota Wildlife Federation's Conservationist of the Year in 2000 (the organization's highest honor) and received IWLA South Dakota Division's Eakins-Ensbury Award of Excellence (the division's highest honor) in 2002.

Clayton exemplifies the League's mission and the League is proud to honor him with this award.

## HALL OF FAME AWARD

*These members achieved a record of outstanding accomplishment in furthering the mission and goals of the League.*



**Stanley and Patricia Jarosz** (Indiana)

Stan and Patty Jarosz are dedicated to the Indiana Division's annual Youth Camp, which celebrated its 50th anniversary in 2012. Stan attended the camp as a child. When he turned 16, he became a junior counselor and life guard. When Stan and Patty started dating, he invited her to spend a couple of days with him at the camp. And the rest, as they say, is history. Stan and Patty married and their children grew up with the Youth Camp.

Stan has been director of the camp for 20 years. He wanted his kids and other children to have a chance to experience the camp he knew and loved. Stan and Patty have kept the camp a place for kids to enjoy the great outdoors.

Today, the staff is mostly made up of former campers. They are drawn back by what the camp stands for and the opportunity to guide new generations of campers. Youth learn about camaraderie, conservation, and the Izaak Walton League. "All week, they go without computers, air conditioning and electricity," says Stan. "There's no video games, no cell phones. It's an opportunity for kids to spend the week out in the wilderness and just have fun, just be kids."

Last year, 120 youth attended the camp — the highest number ever. All told, several thousand kids have had the opportunity to explore the outdoors at the Indiana Division's Youth Camp. And Stan and Patty Jarosz have met most of them.





**Terry McCloskey** (Indiana)

Terry McCloskey has been a member of the Izaak Walton League since 1978. He served as Indiana Division president and had a hand in reinvigorating two chapters that are now thriving. Now a member of the Porter County Chapter, he is leading an initiative to increase the chapter's conservation land holdings — part of a life-long effort to conserve Indiana's natural resources.

In 2011, Terry was the primary mover to raise funds to purchase the Don and Mary Frame Family Conservation Area — 20 acres that straddle the East Branch of the Little Calumet River, which eventually drains into Lake Michigan. He is now negotiating with other landowners, elected officials, and foundations to protect more land in the area.

Terry helped form the Save the Dunes Conservation Fund Land Committee, which acquired nearly 500 acres through purchases and easements and secured \$475,000 in cash contributions from the easement donations.

While Indiana Division president, Terry led litigation against the Eleven County Drainage Board that was trying to levy a new drainage assessment on all properties in the Kankakee River watershed to "clean and snag" the entire length of the Kankakee River in Indiana. The Drainage Board lost this case with the precedent-setting requirement that drainage assessments had to stipulate the benefits to each landowner and that landowners getting more benefits should pay more than those with minimal benefits.

Fellow IWLA Hall of Fame member Charlotte Read says, "Nobody knows the land of northwest Indiana better than Terry McCloskey."



**Byron "Butch" Mezick** (Maryland)

Ikes may remember Butch Mezick from last year's convention, where he gave a closing banquet speech on "Conservation, Firearms, and Leadership." Mezick has been a member of the League's Bethesda-Chevy Chase Chapter since 1990, where he has served in a variety of offices, including president, Board of Governors member, and Endowment Fund member. He currently chairs the chapter's Forestry Committee, Land Acquisition and Fundraising Committee, and Conservation Easement Committee.

As Forestry Committee chairman, Mezick has been a passionate driver of the effort to turn former farm property back into native forest. He has organized hundreds of people for a massive effort to plant and maintain native trees on the property — 1,000 trees each year for the past four years. Mezick tracks tree plantings and outcomes to help inform future efforts. In the busy suburbs outside Washington, DC, the return of native trees will be a boon for people and wildlife.

Under Mezick's leadership, the Conservation Easement Committee has established easements — dedicating land to forest in perpetuity — on 523 acres and is working to add approximately 100 more acres to that total. The chapter has leveraged these easements to raise funds to purchase more land for conservation purposes. Mezick's volunteerism also benefits the local community. With three other chapter members, he educates students in Poolesville High School's Global Ecology Magnet Program, including using bi-annual explorations of the chapter property to explain nature and conservation concepts.



**Herbert and Charlotte Read** (Indiana)

Conservation "power couple" Herb and Charlotte Read are well-known in Indiana and throughout the Great Lakes region. For more than 50 years, they have led efforts to create, expand, and protect the Indiana Dunes National Lakeshore.

Today, the national lakeshore comprises more than 15,000 acres of dunes, oak savannas, swamps, bogs, marshes, prairies, rivers, and forests, including 15 miles of Lake Michigan shoreline. The biological diversity here ranks seventh among all national parks. More than 1,100 flowering plant species and ferns and more than 350 bird species inhabit the area. About 2 million visitors enjoy the national lakeshore each year, including thousands of school children.

The Reads are synonymous with the dunes and successful efforts there. But they don't see saving the dunes as an isolated cause. They know that the air, water, and land around the lakeshore are intertwined with those sands. "I have never known more fearless people," said Tom Dustin, another League legend, about the Reads. "Resolute, determination, exceptional expertise, and the ability to endure combat and strike two blows for every one received are among their characteristics." The Reads have received numerous other awards, including the Sagamore of the Wabash Award, the highest award presented by the Governor of Indiana.

"In conservation, eternal vigilance is a constant," said Charlotte. Herb agrees, saying that victory can be as fleeting as the shifting sands. With these life-long advocates working to protect Indiana's natural resources, we know those sands will not run out.
