TO ALL ATTENDEES AT THE MIDWINTER MEETING**

To protect the health of National Directors, guests, and League staff, attendees (which includes **any person** who expects to be physically present in any room used exclusively for League meetings, meals or any other League function) **will be required to:**

- **Wear a face mask or face covering** in all League meetings except when eating, drinking, or speaking to the assembled group (such as when asking a question or making an oral report). This requirement **applies regardless** of vaccination status; **AND**
- At on-site registration, **provide proof of being fully vaccinated against COVID-19**. Fully vaccinated has the same meaning as the Centers for Disease Control and Prevention (CDC) definition. According to CDC, people are considered fully vaccinated against COVID-19:
 - 2 weeks after their second dose in a 2-dose series, such as the Pfizer-BioNTech or Moderna vaccines, or
 - 2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine.**Proof includes:** an original vaccination card (such as a card issued by the CDC and filled out at the location where you received your vaccination), a printed copy of the vaccination card, a digital copy of such card, or other printed or digital proof of vaccination issued by a local or state health department or pharmacy.
- **If not vaccinated, attendees must have received a negative COVID-19 diagnostic test** (PCR or antigen) within 72 hours of the Midwinter meeting (February 18 for BoD members; February 17 for E-Board members) **AND** provide printed proof of the negative result at on-site registration.
- National Directors who are unwilling to meet these requirements will be excused from the meeting. Division Presidents can appoint a substitute to attend the meeting in lieu of the excused National Director.
- The League will not provide for hybrid attendance or participation.
